

nextbike Czech Republic s.r.o. price list for Czech Republic

This price list is valid for the use of rental bikes offered by nextbike Czech Republic. For nextbike in countries other than Czech Republic and/or partner systems, the terms and conditions of the applicable partners apply.

1) Rates

- a) There is no registration fee charged for the creation of a nextbike customer account.
- b) When booking a fee-based rental, a credit balance has to be created by means of transfer in order to activate the selected payment method. This credit balance may be applied to rentals in all tariff levels and does not expire. The minimum credit amount is 50 CZK.
- c) Normal Fare in Prostějov: First 15 minutes are free of charge. Every other 30 minute interval is for 15 CZK and 150 CZK is for 24 hours rental. Normal Fare in Ostrava: First 15 minutes are free of charge. First 45 minutes, which follow are for 20 CZK. Every other 30 minute interval is for 20 CZK and 150 CZK is for 24 hours rental.
- d) Monthly tariff: 200 CZK per month includes the first 30 minutes of every rental free of charge. Then, according to the normal fare. The monthly subscription is valid for 31 days following the order and its full value is debited instantly. The tariff is only valid for one bike. The minimum contractual period is one month. The tariff will be prolonged automatically if not cancelled 2 weeks before the expiration in writing to nextbike Czech Republic, Libušina 526/101, Olomouc 779 00, Czech Republic or via Email to (servis@nextbikeczech.com).
- e) Annual tariff: 1190 CZK per 365 days. The first 30 minutes of every rental are free of charge. Then, according to the normal fare. The tariff is valid for only one bike. The tariff is automatically cancelled after 365 days.
- f) Details regarding the termination of the monthly and annual tariffs may be found in our GTCs.
- g) Special fares and tariffs may be applied for each city within nextbike Czech Republic brand. These will be displayed on <https://nextbikeczech.com/en> and mobile app.

2) Discounted Rates in Czech Republic

- a) Special conditions apply in many cities as a result of local cooperative agreements. Further information regarding these may be found online. The applicable discounts reduce rental rates for the selected tariffs.
- b) All special conditions apply, as a rule, to one bike only.

3) Additional Fees

- a) It is necessary to verify the credit card before renting your first bike. You will be required to deposit a credit of 50 CZK which can be used in all fare types.
- b) Invoices listing individual rentals may be issued upon customer request. Delivery by email is free of charge. A fee of 30 CZK (50 CZK for non-Euro zone countries) shall be charged for delivery by post.
- c) A service fee of 50 CZK plus the actual expense incurred shall be charged for return-debit transactions.

4) Service Fees

- a) A minimum fee of 250 CZK shall be applied should the rental unit not be returned to an official location (station and virtual station). The right to charge a higher fee in individual cases in which the actual expense incurred is higher than this amount remains unaffected. Return locations may be found online or via the app.
- b) Should the bike be returned incorrectly or not be locked correctly, a service fee up to 250 CZK shall be applied.
- c) Should the bike be stolen as a result of negligence, customer participation (deductible) shall be in the amount of 6000 CZK.
- d) In cases of damage, a fee for actual material and labour costs incurred shall be invoiced. These charges shall not exceed 6000 CZK.



e) In individual cases, nextbike Czech Republic reserves the right to charge service fees in accordance with actual expenses incurred.
